

PUBLIC NOTICE

TO THE CITIZENS OF THE MUNICIPALITY OF PONTIAC

Interested in the bylaw 17-24 to repeal and replace bylaw 02-11 establishing the remuneration of municipal elected officials

IS HEREBY GIVEN by the undersigned Director General of the aforesaid Municipality, that:

- 1. During the regular meeting on October 8, 2024, a notice of motion was given to announce the intention to present a regulation regarding the compensation of municipal officials. The draft regulation was submitted and presented during the same meeting.
- 2. In accordance with the Act respecting the remuneration of elected municipal officials (R.S.Q., c. T-11.001), bylaw No. 17-24 establishing the remuneration of municipal elected officials will be adopted during the regular meeting on November 12, 2024, at 7:30 p.m. at the Luskville Community Center, located at 2024 Route 148, Pontiac.
- 3. The draft bylaw 17-24 is summarized as follows:

Effective January 1, 2024, the Mayor will receive an annual remuneration of \$48,400, or \$4,033 per month, while municipal councillors will receive an annual remuneration of \$16,133, or \$1,344 per month. The Pro-Mayor, designated by the Mayor, will receive a salary equivalent to that of the Mayor when replacing them for a period of 30 consecutive days or more, calculated on a prorated basis for the days of replacement. The remuneration of elected officials will be paid on the first day of each month and applied retroactively to January 1, 2024. The remuneration will be indexed annually based on the Consumer Price Index from Statistics Canada. In the event of the Mayor's departure after serving at least 24 months, a transition allowance equivalent to their bi-monthly salary multiplied by their years of service will be paid.
